Presidents Report: Brett Paradise & Mary Biddle

Dear Members,

Time again for your Yfoundations annual report.

Each year reflecting back over the previous financial year to consider the essence of the events and the work of the board is no easy task. This year is more so than normal . While the board had been aiming to prepare the organisation for the future for some years since the move from Youth Accommodation Association to Yfoundations, the Going Home Staying Home (GHSH) Reform has set an unprecedented pace for all involved.

Keeping up with the reform agenda and potential impacts has taken considerable effort from the board and each of us are extremely aware that the significant proportion of Yfoundations members from Specialist Homelessness Services (SHS) have shared in the efforts to ensure the reform will assist us in our goal to end youth homelessness. We recognise that the overall impacts of the reform for young people remains uncertain and many from the sector are understandably feeling insecure. All involved with Yfoundations, members, board, staff and volunteers need to stay vigilant.

Outside of the GHSH Reform, Yfoundations has continued to aim our sights on broadening the conversations on ending youth homelessness. Making new connections and alliances with the general youth sector, corporates and the community at large. Remaining focused on bringing together the evidence and defining the core foundations that young people need to avoid or move out of homelessness.

This report will outline some of the incredible work that has been undertaken by the staff and many volunteers in the previous year to both engage with and influence the GHSH Reform, progress into new relationships and establish new projects. Each of them need to be commended for the commitment innovation and skill they have shown through this rapid period of uncertainty and change.

To the members of the board that dedicated considerable time, integrity and skill to the governance of the organization, providing strategic deliberation and planning, risk analysis and passion to improve the lives of vulnerable young people. Thank you .

The scene is set for even more uncertainty and change in the coming year. There is no doubt that it will be incredibly difficult, but I am confident that Yfoundations is prepared to progress toward future without youth homelessness.

CEO Annual Report: **Michael Coffey**

Dear Members,

I am pleased to present a report to the Members of Yfoundations for the year 2012-2013.

This year certainly has presented significant challenges, both for Yfoundations and for the youth homelessness sector. In this report I will outline the position that Yfoundations has taken in relation to the Going Home Staying Home (GHSH) reform, other significant issues and achievements for Yfoundations this year will be followed by a overview of Yfoundations operational work and team changes, developed by Colin Stokes further in the report

I have worked with members, staff and young people to develop a cohesive and evidence based position on reform and homelessness more broadly. We are very clear where we stand and we have maintained a consistent position at every forum or meeting we attend. We are determined to continue to be a rational and compassionate voice for the young people and sector whatever changes come our way.

The reforms roll on, soon to take effect with the commencement of GHSH tendering process in November 2013, are as significant as the set up of the Supported Accommodation Assistance Program (SAAP). The current reforms will have a long lasting impact on how young people at risk of or experiencing homelessness in NSW are supported in their pathway out of homelessness. The landscape of the youth homelessness sector in NSW will most likely look very different after June 2014.

With those major potential changes in mind, we have worked in goodwill with both the Government and the sector during the year to try to get the best outcomes for young people through this process. We have participated in the Sector Reference Group, GHSH Working Groups, the Premiers Council







on Homelessness. We made representations to the Minister. We also arranged visits to individual services and organised presentations to individual management committees. We talked about the GHSH reform at networks, inter-agency forums and regular focused general meetings /policy forums/webinars.

We also communicated on this process through newsletters, memos and on Internet. Though, in both government and sector spaces, we are only able to represent information, advise or persuade - but not make the decisions – that is left up to the Government and management committees.

We have had a positive relationship and had some effects in shaping elements of the reforms implementation but the design and general policy assumptions were out of our hands. To the credit of Housing and the reform team, the process has been more respectful and inclusive than in the past. However, some decisions made by the Government and the sector have run contrary to our representations.

We have also joined up with the other two peaks Domestic Violence NSW (DVNSW) and Homelessness NSW on the generic 'homelessness' advocacy in the GHSH reform process and supported initiatives like the Industry Development Fund and Workforce Development Project. As you would expect, Yfoundations has provided separate and expert advocacy on issues particularly relevant to youth homelessness, similarly DVNSW on issues relevant to women and children escaping domestic violence who become homeless.

As you would all know, the pathways out of homelessness for young people are so much more complex. We have greater aspirations for our young people than just secure housing – housing is only a part of it.

We are not just looking for housing solutions. We are worried about the push back of the GHSH reform on Out Of Home Care (OOHC), Juvenile Justice, schools and other services and about what it will mean for young people if there are any reductions of services/beds in any region, both in urban or regional NSW.

Whilst it may be possible to create minor efficiencies through the reform process, we still think the resource base is not adequate. We are calling on the State and Federal Government:

- To invest in young people and continue to properly fund the SHS and HAP projects after June 2014

- To increase the budget rather than reduce it, so that we avoid throwing children and young people out into the cold as services are reduced.

If the money cannot come from FACS, it needs to be found from somewhere else in the NSW Budget and we have some ideas about that. To date, Yfoundations has approached the reform process with a single policy proposition: whatever changes occur, it must result in better outcomes, better support options and more opportunities for all young people in NSW affected by homelessness, family breakdown, domestic and family violence, unemployment, underemployment, discrimination and disconnection from education. Anything less is unacceptable.

We hold that position throughout the year.



As we said to business leaders and a cross section of community and NGO leaders at our recent successful "Investing in Youth " employment conference in Sydney – 'we mean business'.

Furthermore, Yfoundations believes that, in order to end youth homelessness or to achieve a genuine systemic reform of how the work of ending youth homelessness is done, more people than just people from the housing sector are needed at the table. Obviously in the youth space we need Child Protection, Out Of Home Care, Juvenile Justice, Vulnerable Teen services, Reconnect and Family Support Services.

If I can park the GHSH to the side for a moment, other significant issues loomed this year such as the SHS transitional Housing rent and asset management reforms, changes to TILA, inertia at the commonwealth level on the NAHA, NPAH and "A Road Home" process, the Federal election and the lack of prominence of youth and homelessness in the policy debate.

Some good news is that, despite uncertainty about the future funding of peaks, we are still at the table advocating for young people for a more sophisticated, a deeper understanding and a better response to youth homelessness and the drivers of homelessness. We continue our ongoing dialogue with the Government at the local, state and federal levels, with corporate leaders, with the local services and members and increasingly with young people and other community activists.

Recently, we were really encouraged and very excited by the offer from Minister Goward to help us set up a Youth Housing Company for the sector, designed by the sector, specifically as a site for dedicated youth housing. Minister Goward offered an additional \$12.5 million housing stock for this project. We are currently working with the department and members at setting the Youth Housing Company up.

The Yfoundations team has been busy all year directly assisting directly young people, strengthening the policy and governance agenda, delivering public events and consultations and supporting youth services. Colin Stokes, as the Acting Operations Manager, presents a report on this work following my report here.

There has been great team cohesion, purpose and camaraderie thanks to the expert and canny leadership of Catherine Francetich, who has sadly recently moved on. Catherine also did a spectacular job in the lead, design and running of the recent "Investing in Youth " Employment Conference. Catherine has left Yfoundations in a strong position to explore new horizons. Special thanks to Catherine for her contribution and we wish her luck for future endeavours.

I would like to thank you, our members, as well as our networks, partners. I thank

especially the board members and the board member's services, for contributing to the work of Yfoundations in 2013. The board members, in particular, have put in lots of extra hours attending GHSH working groups and representing Yfoundations at meetings both local and statewide. Special thanks to Brett and Mary for their leadership, especially to Brett for covering me as the CEO, during my absences this year.

To conclude, due to unforeseen family circumstances, I have had to take a few extended breaks throughout the year. In my absence I have had to ask so much more from the Yfoundations staff during 2013. They were up to this challenge. I continue to be proud of the dedication, innovation, initiative, flexibility and commitment that they have demonstrated throughout the year to ensure we stay on track in our work.

These are 'interesting' times, and the Yfoundations team will continue our direct work and systemic advocacy to ensure that young people are best enabled by a social structures where a young people's pathway out of homelessness sets them up to live thriving, independent and stable lives, with all their foundations in place.

Programs Report: Colin Stokes

It is quite a task to write a report for the Yfoundations team. So many of the small things that keep Yfoundations going don't show up as events or milestones. Yfoundations' staff are the best resource we have and I thank them for their continued commitment to this organisation and the young people we serve.

Yfoundations said farewell to a few staff this year, including Brandon Bear and Sammy Beck from the Health Team, Grace Stubee from communications and Chris Hartley who worked in policy. We thank them for their efforts and wish them well.

While Catherine Francetich left after June, I want to thank her for her efforts building up the team and keeping us all on track. She will be missed.

Of course we also get to welcome new staff, Jessica Fielding, Ben Corio and Sophie Thievenaz, and I am glad to have joined the team as well. Existing staff have expanded their roles and skills, with Jessie Halligan taking on a range of new tasks and Silvia joining the Health Team.

We also want to acknowledge all the young people, volunteers and students that helped us throughout the year. Our programs and work lives would be less rich without them.

Yfoundations made real progress developing our participation plan and have developed some great relationships with young people, leading to more effective and relevant programs. This will continue with the funding of the Generation Yes program – keep an eye out for youth participation activities near you.

The Health Team has completed our first regional training run and anticipate getting out into the state even more this year. We have also been funded to provide training for Yhunger, a program that we helped develop that invites young people to engage with food, nutrition and exercise.

In total we trained 186 youth and allied workers about sexual health and the evaluations of this training are overwhelmingly positive, with 100% saying they have increased capacity to work with young people on this delicate issue.

Health Team development included building a new partnership with the Aboriginal Health and Medical Research Council to develop culturally appropriate resources for Indigenous young people, based around the One to One resource.

Once again Yfoundations had a fun presence at Mardi Gras Fair Day and continued our engagement with the LGBTIQ community through our work with Twenty10, including running a leadership program for the Out West group.



Yfoundations staff engaged with over 600 young people through events, including

- Mardi Gras Fair Day
- Youth Homelessness Matters Day
- Liverpool Schools Service Expo
- Sexual Health Week
- Youth Week Sexual Health Parliament
- Reiby Service Expo

20 years after starting, Youth Homelessness Matters Day underwent a restructure, adding a partnership group to give strategic and operational advice. The program changes also included a video campaign, involvement of a campaign ambassador and a revision of handout fact sheets.

Communications has continued to work on brand awareness and consistency with sweeping changes to the Member's Memo and E-newsletter. Improvements to the website and much deeper engagement in social media such as Twitter and Facebook have already produced results, and plans are afoot for a significant redevelopment of the Yfoundations website.

Yfoundations fundraising capacity is greatly increased, having met all governmental compliance requirements to hold our own events and receive funds from external supporters. We are registered on the GoFundraise website and volunteers willing to fundraise for us can now do this with a minimum of fuss. Yconnect is a vital core service for young people experiencing or at risk of homelessness and the webpage received 89258 visitors over the year. There were 2537 phone calls for the same period.

The Yconnect webpage is now smartphone and tablet compatible, increasing the reach and effectiveness of the service. An app developed in partnership with the Inner City Youth at Risk project uses Yconnect and other data to contribute to a GPS linked service directory app for young people at risk. This is the sort of innovation that will keep Yfoundations relevant for years to come.

The staff at Yfoundations continue to show courage, passion and intelligence in their approach to young people and homelessness. We work hard to keep our team cohesion, from our daily lunchtime quiz to social and team building events. I myself have gained 10 kilograms, partly as a result of the pot-luck picnics and home made birthday cakes. I am proud to work with this awesome team.

Foundations Report: Jessica Fielding

For young people experiencing homelessness, who lack the safety net and support of family, friends, mentors, school or work peers, the years of childhood and adolescence can be extremely challenging. Young people's social and emotional health and education are significantly affected by homelessness. Homelessness inhibits the physical, emotional, cognitive, social, and behavioral development of children and young people.

We know that the experience of homelessness for a young person is fundamentally different to the lived experience of adults. With appropriate interventions, young people can transition out of homelessness as their personal situation, employment and career direction stabilises. However achieving a transition out of homelessness can be more difficult for adults who become chronically homeless.

Young people experiencing homelessness are challenged with managing the conventional 'normal' developmental issues experienced during this formative stage of life, as well as having to cope with the constant confrontations that arise from living without a physical home or stable place in the world. Young homeless people are more likely to be involved in criminal activities as a perpetrator or victim, to be disengaged from mainstream education, experience nutritional deficits and/ or other food insecurity issues and to have experienced or witnessed domestic violence and abuse. The daily struggle of survival takes precedence over the more 'expected' challenges presented throughout childhood and adolescence. In addition, young people who have experienced homelessness are more likely than others to find themselves homeless as adults.

We recognise that each young person arrives with a distinct, complex and multifaceted story. It is therefore vital that the support provided recognises this diversity and is targeted, holistic and effective in responding to the unique needs of the young person. After extensive research examining child and adolescent development and youth homelessness, Yfoundations has identified five core foundations as integral to the process of ending youth homelessness. These foundations are Connections, Home and Place, Education & Employment, Health & Wellness and Safety and Stability. While their relevance will vary on the basis of individual difference, each foundation is necessary and equal in importance, if a young person is to end their experience of youth homelessness.



A small snapshot of the foundation is as follows.

Connections

It is vital that all young people are given the opportunity to develop and nurture the connections in their lives. Connections to friends, family, community and society promote resilience and social inclusion. Connections ensure that young people are protected from deleterious and risky behaviours during a formative developmental stage.











Home and Place

It is vital that all young people have access to a safe, non-judgmental home and place -A comfortable place that they identify with and belong to. A Home and Place should be an environment that promotes growth and fosters positive development.

Health & Wellness

It is vital that all young people, particularly during the formative stages of their growth and development, are physically, socially and emotionally well. To ensure this, young people must have access to all the necessary prerequisites for achieving health & wellness. Being well and feeling healthy will promote self-worth and ensure young people feel competent to contribute and participate in society.

Education & Employment

It is vital that all young people are given the opportunity to pursue their educational and professional goals. Education & employment is crucial to the growth and development of young people. Education & employment, including formal tuition and practical life skills, promotes self-confidence and independence and provides young people with the skills and competencies necessary to enter adulthood.

Safety and Stability

It is vital that all young people not only feel safe, but are actually protected from risk factors that may impede their developmental process. Young people must have the internal and external support mechanisms that enable them to build the confidence and independence to actively participate in and contribute to society.



The financial report has been prepared on the basis of historical cost and does not take into consideration changing values of money or current valuations of non current assets. Cost is based on the fair values of the consideration given in exchange for assets.

(b)Significant accounting judgments, estimates & assumptions.

The preparation of financial statements requires management to make judgements, estimates & assumptions that affect the application of policies and reported amounts of assets, liabilities, income & expenses. The estimates and associated assumptions are based on historical experience and other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making judgments. Actual results may differ from these estimates The estimates & underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period or in the period of the revision and future periods if the revision affects both current & future periods.

(c)Revenue Recognition

Revenue is recognised when the association is legally entitled to the income and the amount can be quantified with reasonable accuracy and is net of GST.

(d)Expenditure

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category

(e) Cash

Cash & Cash equivalents in the balance sheet comprise cash at bank and in hand and in short term deposits are stated at their nominal value

(f) Trade Debtors

Trade Debtors are stated at original invoice amount less any Provision for doubtful debts where applicable. Normal trading terms are 7 to 30 days

(d) Plant & Equipment

Fixed assets are written off in the year of expenditure.

(e) Grants in Advance

Grants in Advance are carried forward at their original amount and are to be provided subsequent

to the balance date

(f) Employee Leave

The liability for Annual & Long Service Leave is recognised and measured at the amount expected to be paid when liabilities are settled

(g) Provisions

These are recognised when there is a present obligation as a result of past funding and it is

probable that an outflow will be required using reasonable estimates.

(h) Government Grants

Grants are matched against expenditure in the year expenditure is incurred and in accordance with funding body requirements when services are performed or conditions fulfilled
